## \* Notes

- 2.1. Storage fees are not charged for **live animals** received at the Border Veterinary Inspection Post between 21:00 and 24:00 and released the following day no later than 03:00, provided that the importer/owner (or authorised representative) demonstrably makes due efforts to collect the consignment during this period, including veterinary and customs clearance.
- 2.2. Storage fees for consignments of live animals are charged **from the second day** of storage inclusive.
- 2.3.  
2.3.1. Storage fees for consignments of products of animal origin are charged **from the fourth day** of storage inclusive.
- 3.2. For disposal of consignments exceeding 66 kg, **both the flat consignment fee and the weight-based fee** are charged.

If the expected total payment exceeds CZK 100,000 including VAT, Prague Airport, a. s. is entitled to request advance payments repeatedly in the amount of 90 % of the estimated costs of Border Veterinary Inspection Post services as of the billing date. The total amount of advance payments must be credited to the Prague Airport bank account prior to release of the consignment.
